Additional use of instructor and driver's training car for a test service is \$85.00.  
Additional behind-the-wheel instruction is \$85.00 for a 2- hour lesson.

In order to schedule in-car lessons, tuition must be paid in full, student must show temporary permit, and have completed at least one classroom session.

There is a \$10 fee for re-taking the final classroom test.

**The Teen Certificate of Completion will be mailed to the student address listed above 10 days after completing the entire program.**

After 14 days, there will be a \$25.00 fee for a duplicate certificate.

Driver Training Schools are monitored by the Ohio Department of Public Safety, Ohio Traffic Safety Office, 1970 West Broad Street, Columbus, OH 43233. The Driving school shall furnish a licensed instructor and a motor vehicle for instruction. By state law, **driving schools do not guarantee issuance of a driver's license to the student.**

Students who fail to cancel or reschedule an in-car lesson more than **five days prior** to a scheduled in-car lesson, or do not have their temporary permit for a scheduled in-car lesson will be charged \$50.00 per lesson.

The parent or guardian, or person having sole custody, shall be jointly and severally liable to this agreement.

There is a \$30.00 charge for all returned checks. We do not re-deposit returned checks.

The undersigned student and parent, guardian, or person having sole custody certifies that they have read, understands and has received a copy of this agreement.
